

Marine Navigation Levy

Marine Navigation (Regulatory Functions) Levies Protection of the Sea Levy

As from 1 July 2014, the Protection of the Sea Levy (PSL) will decrease from 14.25 cents to 11.25 cents per net ton. The rate of 11.25 cents per net ton is consistent with the PSL rate prior to 1 April 2010.

The schedule of rates for the Marine Navigation Levy (MNL), Marine Navigation (Regulatory Functions) Levies (RFL) remain unchanged from those applicable at 1 July 2004 and are listed below.
