# Marine safety (NSCV Parts E and F) Exemption 2014

I, Graham Peachey, Chief Executive Officer of the Australian Maritime Safety Authority (the National Marine Safety Regulator under section 9 of the *Marine Safety (Domestic Commercial Vessel) National Law*), make this instrument under subsection 143(1) of the *Marine Safety (Domestic Commercial Vessel) National Law*.

### 1 Name of instrument

This instrument is Marine safety (NSCV Parts E and F) Exemption 2014.

#### 2 Duration

This instrument:

- (a) commences when it is made; and
- (b) ceases to have effect at the end of 31 July 2016.

### 3 Repeal

Marine safety (safety management systems) Exemption 2013 is repealed.

### 4 Definitions

In this instrument:

existing vessel — see section 7 of Marine Order 504.

Marine Order 504 means Marine Order 504 (Certificates of operation) 2013

Marine Safety (Domestic Commercial Vessel) National Law — see Schedule 1 to the Marine Safety (Domestic Commercial Vessel) National Law Act 2012.

Note National Regulator is defined in the Marine Safety (Domestic Commercial Vessel) National Law — see section 6.

# 5 Exemption — application for certificate of operation

- (1) This section applies to a person who applies, under Marine Order 504, for a certificate of operation for an existing vessel.
- (2) The person is exempt from compliance with paragraph 10(c) of Marine Order 504 if:
  - (a) for a class 1, 2 or 3 vessel the vessel operates under a safety management system that complies with NSCV Part E as in force either on 30 June 2013 or on 1 July 2013; or
  - (b) for a class 4 vessel the vessel operates under a safety management plan that complies with NSCV Part F.

# 6 Exemption — extension of date for compliance

A person is exempt from the requirement to comply with the condition of a certificate of operation:

- (a) for a class 1 existing vessel mentioned in subparagraph 11(1)(e)(ii) of Marine Order 504; or
- (b) for a class 4 existing vessel mentioned in paragraph 48(4)(a) of the *Marine Safety (Domestic Commercial Vessel) National Law* as modified by subparagraph 16(3)(a)(iii) of the *Marine Safety (Domestic Commercial Vessel) National Law Regulation 2013*.

### 7 Conditions

For section 6, the vessel must:

- (a) comply with the operational practices, emergency management requirements, crewing requirements, safety management requirements and audit requirements that applied to the kind of vessel on 30 June 2013; and
- (b) for a class 1 vessel comply with Part E of the NSCV by 1 July 2015; and
- (c) for a class 4 vessel comply with Part F of the NSCV by 1 July 2015.
