## **6 Delegation**

A person holding or performing the duties of a position in AMSA is delegated the power of AMSA or the National Marine Safety Regulator in accordance with Schedules 1 to 14.

*Note* A delegate of the National Marine Safety Regulator is subject to the National Marine Safety Regulator's directions in exercising delegated powers and performing delegated functions — see subsection 11(2) of the national law.

## **7 Authorisation**

A person holding or performing the duties of a position in AMSA is authorised to exercise the power of the National Marine Safety Regulator under the national law in accordance with Schedule 14.

## **8 Change of title of position or class of positions**

If there is a change to the title of a position or class of positions mentioned in any Schedule, that does not in and of itself affect the power that is permitted to be exercised in accordance with this instrument.

*Note* The effect of this provision is that despite a title change, a position is permitted to continue to exercise a power in accordance with this instrument until there has been an express change in writing to the power delegated or authorised to be exercised.
